<b>Skin Contact</b>	<p>If solids or aerosol mists are deposited upon the skin:</p> <ul style="list-style-type: none"> <li>▶ Flush skin and hair with running water (and soap if available).</li> <li>▶ Remove any adhering solids with industrial skin cleansing cream.</li> <li>▶ <b>DO NOT use solvents.</b></li> <li>▶ Seek medical attention in the event of irritation.</li> </ul>

**Indication of any immediate medical attention and special treatment needed**

for intoxication due to Freons/ Halons;

A: Emergency and Supportive Measures

- ▶ Maintain an open airway and assist ventilation if necessary
- ▶ Treat coma and arrhythmias if they occur. Avoid (adrenaline) epinephrine or other sympathomimetic amines that may precipitate ventricular arrhythmias. Tachyarrhythmias caused by increased myocardial sensitisation may be treated with propranolol, 1-2 mg IV or esmolol 25-100 microgm/kg/min IV.
- ▶ Monitor the ECG for 4-6 hours

B: Specific drugs and antidotes:

- ▶ There is no specific antidote

C: Decontamination

- ▶ Inhalation; remove victim from exposure, and give supplemental oxygen if available.
- ▶ Ingestion; (a) Prehospital: Administer activated charcoal, if available. **DO NOT** induce vomiting because of rapid absorption and the risk of abrupt onset CNS depression. (b) Hospital: Administer activated charcoal, although the efficacy of charcoal is unknown. Perform gastric lavage only if the ingestion was very large and recent (less than 30 minutes)

D: Enhanced elimination:

- ▶ There is no documented efficacy for diuresis, haemodialysis, haemoperfusion, or repeat-dose charcoal.

- ▶ Do not administer sympathomimetic drugs unless absolutely necessary as material may increase myocardial irritability.
- ▶ No specific antidote.
- ▶ Because rapid absorption may occur through lungs if aspirated and cause systematic effects, the decision of whether to induce vomiting or not should be made by an attending physician.
- ▶ If lavage is performed, suggest endotracheal and/or esophageal control.
- ▶ Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach.
- ▶ Treatment based on judgment of the physician in response to reactions of the patient

Treat symptomatically.

Following acute or short term repeated exposures to n-hexane:

- ▶ Large quantities of n-hexane are expired by the lungs after vapour exposure (50-60%). Humans exposed to 100 ppm demonstrate an n-hexane biological half life of 2 hours.
- ▶ Initial attention should be directed towards evaluation and support of respiration. Cardiac dysrhythmias are a potential complication.

**INGESTION:**

- ▶ Ipecac syrup should be considered for ingestion of pure hexane exceeding 2-3ml/kg. Extreme caution must be taken to avoid aspiration since small amounts of n-hexane intratracheally, produce a severe chemical pneumonitis.

**BIOLOGICAL EXPOSURE INDEX - BEI**

BEIs represent the levels of determinants which are most likely to be observed in specimens collected in a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the Exposure Standard (ES or TLV).

NS: Non-specific determinant; Metabolite observed following exposure to other materials.

SQ: Semi-quantitative determinant; Interpretation may be ambiguous - should be used as a screening test or confirmatory test.

For acute or short term repeated exposures to perchloroethylene:

- ▶ Tetrachloroethylene / perchloroethylene is well absorbed through the lungs with peak levels more important than duration in determining blood concentration. Lungs excrete most of the absorbed tetrachloroethylene in an unchanged state; about 3% is converted by the liver to form trichloroacetic acid and subsequently excreted by the kidney. Exhaled material has a biological half-life of 65 hours.

**INHALATION:**

- ▶ The treatment of acute inhalation exposures is supportive with initial attention directed to evaluation / support of ventilation and circulation. As with all hydrocarbons care must be taken to reduce the risk of aspiration by proper positioning and medical observation.

**INGESTION:**

- ▶ The ingestion level at which emesis should be induced is difficult to predict in the absence of extensive human studies.
- ▶ The role of charcoal and cathartics remains uncertain.

**SMALL FIRE:**

- ▶ Water spray, dry chemical or CO2

**LARGE FIRE:**

- ▶ Water spray or fog.

**Special hazards arising from the substrate or mixture****Fire Incompatibility**

- ▶ Avoid contamination with oxidising agents i.e. nitrates, oxidising acids, chlorine bleaches, pool chlorine etc. as ignition may result

**Advice for firefighters****Fire Fighting****FOR FIRES INVOLVING MANY GAS CYLINDERS:**

- ▶ To stop the flow of gas, specifically trained personnel may inert the atmosphere to reduce oxygen levels thus allowing the capping of leaking container(s).
- ▶ Reduce the rate of flow and inject an inert gas, if possible, before completely stopping the flow to prevent flashback.
- ▶ **DO NOT extinguish the fire until the supply is shut off** otherwise an explosive re-ignition may occur.
- ▶ If the fire is extinguished and the flow of gas continues, used increased ventilation to prevent build-up, of explosive atmosphere.
- ▶ Use non-sparking tools to close container valves.
- ▶ Be CAUTIOUS of a Boiling Liquid Evaporating Vapour Explosion, *BLEVE*, if fire is impinging on surrounding containers.
- ▶ Direct 2500 litre/min (500 gpm) water stream onto containers above liquid level with the assistance remote monitors.
- ▶ Alert Fire Brigade and tell them location and nature of hazard.
- ▶ May be violently or explosively reactive.
- ▶ Wear breathing apparatus plus protective gloves.
- ▶ Prevent, by any means available, spillage from entering drains or water course.
- ▶ If safe, switch off electrical equipment until vapour fire hazard removed.
- ▶ Use water delivered as a fine spray to control fire and cool adjacent area.
- ▶ **DO NOT** approach containers suspected to be hot.
- ▶ Cool fire exposed containers with water spray from a protected location.
- ▶ If safe to do so, remove containers from path of fire.
- ▶ Equipment should be thoroughly decontaminated after use.

**GENERAL**

- ▶ Alert Fire Brigade and tell them location and nature of hazard.
- ▶ May be violently or explosively reactive.
- ▶ Wear breathing apparatus plus protective gloves.
- ▶ Consider evacuation
- ▶ Fight fire from a safe distance, with adequate cover.
- ▶ If safe, switch off electrical equipment until vapour fire hazard removed.
- ▶ Use water delivered as a fine spray to control fire and cool adjacent area.
- ▶ **DO NOT approach cylinders suspected to be hot.**
- ▶ Cool fire-exposed cylinders with water spray from a protected location.
- ▶ If safe to do so, remove containers from path of fire.

**FIRE FIGHTING PROCEDURES:**

- ▶ The only safe way to extinguish a flammable gas fire is to stop the flow of gas.
- ▶ If the flow cannot be stopped, allow the entire contents of the cylinder to burn while cooling the cylinder and surroundings with water from a suitable distance.
- ▶ Extinguishing the fire without stopping the gas flow may permit the formation of ignitable or explosive mixtures with air. These mixtures may propagate to a source of ignition.

**SPECIAL HAZARDS**

- ▶ Excessive pressures may develop in a gas cylinder exposed in a fire; this may result in explosion.
- ▶ Cylinders with pressure relief devices may release their contents as a result of fire and the released gas may constitute a further source of hazard for the fire-fighter.
- ▶ Cylinders without pressure-relief valves have no provision for controlled release and are therefore more likely to explode if exposed to fire.

**FIRE FIGHTING REQUIREMENTS:**

The need for proximity, entry and flash-over protection and special protective clothing should be determined for each incident, by a competent fire-fighting safety professional.

**Fire/Explosion Hazard**

- ▶ Liquid and vapour are highly flammable.
- ▶ Severe fire hazard when exposed to heat or flame.
- ▶ Vapour forms an explosive mixture with air.
- ▶ Severe explosion hazard, in the form of vapour, when exposed to flame or spark.
- ▶ Vapour may travel a considerable distance to source of ignition.
- ▶ Heating may cause expansion or decomposition with violent container rupture.
- ▶ Aerosol cans may explode on exposure to naked flames.
- ▶ Rupturing containers may rocket and scatter burning materials.
- ▶ Hazards may not be restricted to pressure effects.
- ▶ May emit acrid, poisonous or corrosive fumes.
- ▶ On combustion, may emit toxic fumes of carbon monoxide (CO).

<b>Safe handling</b>	<p>The conductivity of this material may make it a static accumulator., A liquid is typically considered nonconductive if its conductivity is below 100 pS/m and is considered semi-conductive if its conductivity is below 10 000 pS/m., Whether a liquid is nonconductive or semi-conductive, the precautions are the same., A number of factors, for example liquid temperature, presence of contaminants, and anti-static additives can greatly influence the conductivity of a liquid.</p> <p>Natural gases contain a contaminant, radon-222, a naturally occurring radioactive gas. During subsequent processing, radon tends to concentrate in liquefied petroleum streams and in product streams having similar boiling points. Industry experience indicates that the commercial product may contain small amounts of radon-222 and its radioactive decay products (radon daughters). The actual concentration of radon-222 and radioactive daughters in process equipment (IE lines, filters, pumps and reactor units) may reach significant levels and produce potentially damaging levels of gamma radiation. A potential external radiation hazard exists at or near any pipe, valve or vessel containing a radon enriched stream or containing internal deposits of radioactive material. Field studies, however, have not shown that conditions exist that expose the worker to cumulative exposures in excess of general population limits. Equipment containing gamma-emitting decay products should be presumed to be internally contaminated with alpha-emitting decay products which may be hazardous if inhaled or ingested. During maintenance operations that require the opening of contaminated process equipment, the flow of gas should be stopped and a four hour delay enforced to allow gamma-radiation to drop to background levels. Protective equipment (including high efficiency particulate respirators (P3) suitable for radionuclides or supplied air) should be worn by personnel entering a vessel or working on contaminated process equipment to prevent skin contamination or inhalation of any residue containing alpha-radiation. Airborne contamination may be minimised by handling scale and/or contaminated materials in a wet state. No chronic systemic effects have been reported from occupational exposure to LPG. The TLV-TWA is based on good hygiene practices and is thought to minimise the risk of fire or explosion.

Butane in common with other homologues in the straight chain saturated aliphatic hydrocarbon series is not characterised by its toxicity but by its narcosis-inducing effects at high concentrations. The TLV is based on analogy with pentane by comparing their lower explosive limits in air. It is concluded that this limit will protect workers against the significant risk of drowsiness and other narcotic effects.

Odour Safety Factor(OSF)

OSF=0.22 (n-BUTANE)

For n-hexane:

Occupational polyneuropathy may result from exposures as low as 500 ppm (as hexane), whilst nearly continuous exposures of 250 ppm have caused neurotoxic effects in animals.

Many literature reports have failed to distinguish hexane from n-hexane and on the assumption that the commercial hexane contains 30% n-hexane, a worst case recommendation for TLV is assumed to reduce the risk of peripheral neuropathies (due to the metabolites 2,5-heptanedione and 3,6-octanedione) and other adverse neuropathic effects.

Concurrent exposure to chemicals (including MEK) and drugs which induce hepatic liver oxidative metabolism can reduce the time for neuropathy to appear.

Odour Safety Factor(OSF)

OSF=0.15 (n-HEXANE)

Odour Threshold Value for tetrachloroethylene (perchloroethylene): 47 ppm (detection), 71 ppm (recognition)

NOTE: Detector tubes for perchloroethylene, measuring in excess of 10 ppm, are commercially available.

Exposure at or below the TLV-TWA is thought to prevent discomfort and subjective complaints arising during controlled human studies and prolonged industrial exposure to perchloroethylene at 100 ppm and 200 ppm.

The STEL is recommended to minimise the potential of anaesthetic effects.



## SECTION 11 Toxicological information

### Information on toxicological effects

<b>Inhaled</b>	<p>Inhalation of vapours may cause drowsiness and dizziness. This may be accompanied by narcosis, reduced alertness, loss of reflexes, lack of coordination and vertigo.</p> <p>No health effects were seen in humans exposed at 1,000 ppm isobutane for up to 8 hours or 500 ppm for 8 hours/day for 10 days. Isobutane can have anaesthetic and asphyxiant effects at high concentrations, well above the lower explosion limit of 1.8% (18,000 ppm).</p> <p>Butane is a simple asphyxiant and is mildly anaesthetic at high concentrations (20-25%). 10000 ppm for 10 minutes causes drowsiness. Narcotic effects may be accompanied by exhilaration, dizziness, headache, nausea, confusion, incoordination and unconsciousness in severe cases</p> <p>Exposure to high concentrations of fluorocarbons may produce cardiac arrhythmias or cardiac arrest due sensitisation of the heart to adrenalin or noradrenalin. Deaths associated with exposures to fluorocarbons (specifically halogenated aliphatics) have occurred in occupational settings and in inhalation of bronchodilator drugs.</p> <p>Bronchospasm consistently occurs in human subjects inhaling fluorocarbons. At a measured concentration of 1700 ppm of one of the commercially available aerosols there is a biphasic change in ventilatory capacity, the first reduction occurring within a few minutes and the second delayed up to 30 minutes. Most subjects developed bradycardia (reduced pulse rate).</p> <p>Bradycardia is encountered in dogs when administration is limited to upper respiratory tract (oropharyngeal and nasal areas). Cardiac arrhythmias can be experimentally induced in animals (species dependency is pronounced with dogs and monkeys requiring lesser amounts of fluorocarbon FC-11 than rats or mice). Sensitivity is increased by injection of adrenalin or cardiac ischaemia/necrosis or pulmonary thrombosis/bronchitis. The cardiotoxic effects of the fluorocarbons originate from irritation of the respiratory tract which in turn reflexively influences the heart rate (even prior to absorption of the fluorocarbon) followed by direct depression of the heart after absorption.</p> <p>Exposure to fluorocarbon thermal decomposition products may produce flu-like symptoms including chills, fever, weakness, muscular aches, headache, chest discomfort, sore throat and dry cough. Complete recovery usually occurs within 24 hours of exposure.</p> <p>The paraffin gases C1-4 are practically nontoxic below the lower flammability limit, 18,000 to 50,000 ppm; above this, low to moderate incidental effects such as CNS depression and irritation occur, but are completely reversible upon cessation of the exposure.</p> <p>The vapour is discomforting</p> <p><b>WARNING: Intentional misuse by concentrating/inhaling contents may be lethal.</b></p> <p>Inhalation hazard is increased at higher temperatures.</p> <p>Acute effects from inhalation of high concentrations of vapour are pulmonary irritation, including coughing, with nausea; central nervous system depression - characterised by headache and dizziness, increased reaction time, fatigue and loss of co-ordination</p> <p>Central nervous system (CNS) depression may include nonspecific discomfort, symptoms of giddiness, headache, dizziness, nausea, anaesthetic effects, slowed reaction time, slurred speech and may progress to unconsciousness. chromodacryorrhoea and ataxia within the first 24 hours. Symptoms disappeared after 24 hours. Several studies have evaluated sensory irritation in laboratory animals or odor or sensory response in humans. When evaluated by a standard procedure to assess upper airway irritation, isoparaffins did not produce sensory irritation in mice exposed to up to 400 ppm isoparaffin in air. Human volunteers were exposed for six hours to 100 ppm isoparaffin. The subjects were given a self-administered questionnaire to evaluate symptoms, which included dryness of the mucous membranes, loss of appetite, nausea, vomiting, diarrhea, fatigue, headache, dizziness, feeling of inebriation, visual disturbances, tremor, muscular weakness, impairment of coordination or paresthesia. No symptoms associated with solvent exposure were observed. With a human expert panel, odour from liquid imaging copier emissions became weakly discernible at approximately 50 ppm.

Numerous long-term exposures have been conducted in animals with only one major finding observed. Renal tubular damage has been found in kidneys of male rats upon repeated exposures to isoparaffins. It does not occur in mice or in female rats. This male rat nephropathy has been observed with a number of hydrocarbons, including wholly vaporized unleaded gasoline. The phenomenon has been attributed to reversible binding of hydrocarbon to alpha2-globulin. Since humans do not synthesize alpha2-globulin or a similar protein, the finding is not considered to be of biological significance to man. No clinically significant renal abnormalities have been found in refinery workers exposed to hydrocarbons. When evaluated for developmental toxicity in rats, isoparaffins were neither embryotoxic nor teratogenic. Isoparaffins were consistently negative on standard bacterial genotoxicity assays. They were also non-genotoxic in *in vivo* mammalian testing for somatic or germ cell mutations (mouse micronucleus test and rat dominant lethal assay, respectively).

Acute intoxication by halogenated aliphatic hydrocarbons appears to take place over two stages. Signs of a reversible narcosis are evident in the first stage and in the second stage signs of injury to organs may become evident, a single organ alone is (almost) never involved.

Depression of the central nervous system is the most outstanding effect of most halogenated aliphatic hydrocarbons. Inebriation and excitation, passing into narcosis, is a typical reaction. In severe acute exposures there is always a danger of death from respiratory failure or cardiac arrest due to a tendency to make the heart more susceptible to catecholamines (adrenalin)

Material is highly volatile and may quickly form a concentrated atmosphere in confined or unventilated areas. The vapour may displace and replace air in breathing zone, acting as a simple asphyxiant. This may happen with little warning of overexposure.

Symptoms of asphyxia (suffocation) may include headache, dizziness, shortness of breath, muscular weakness, drowsiness and ringing in the ears. If the asphyxia is allowed to progress, there may be nausea and vomiting, further physical weakness and unconsciousness and, finally, convulsions, coma and death. Significant concentrations of the non-toxic gas reduce the oxygen level in the air. As the amount of oxygen is reduced from 21 to 14 volume %, the pulse rate accelerates and the rate and volume of breathing increase. The ability to maintain attention and think clearly is diminished and muscular coordination is somewhat disturbed. As oxygen decreases from 14-10% judgement becomes faulty; severe injuries may cause no pain. Muscular exertion leads to rapid fatigue. Further reduction to 6% may produce nausea and vomiting and the ability to move may be lost. Permanent brain damage may result even after resuscitation at exposures to this lower oxygen level. Below 6% breathing is in gasps and convulsions may occur. Inhalation of a mixture containing no oxygen may result in unconsciousness from the first breath and death will follow in a few minutes.

Accidental high level exposure to tetrachloroethylene (perchloroethylene) has produced lightheadedness, unconsciousness and liver and kidney damage in workers. In at least two cases such exposures were fatal. Sudden death resulting from acute exposure to anesthetic vapor concentrations is presumed to result from either excessive depression of the respiratory center or the onset of a fatal cardiac arrhythmia induced by epinephrine sensitisation.

The nervous system is a major target organ in humans exposed to tetrachloroethylene by inhalation.

Acute exposure, depending on concentration, can result in reversible mood and behavioral changes, impairment of coordination, or anesthetic effects. The anesthetic and preanesthetic central nervous system effects of tetrachloroethylene were documented in four volunteer subjects (one male, sex not specified for the other three) exposed acutely to concentrations ranging from 500 to 2,000 ppm. Mood changes, slight ataxia, faintness, and dizziness occurred with exposure to concentrations of 1,000-1,500 ppm for <2 hours. At exposure to 2,000 ppm for 5-7 minutes, subjects experienced a sensation of impending collapse. Slight lightheadedness was reported by six male volunteers exposed to tetrachloroethylene at a concentration of 210-240 ppm for over 30 minutes. Dizziness has been reported after brief accidental exposure to high concentrations of tetrachloroethylene fumes while longer exposures resulted in collapse, coma, and seizures. There have been several experimental studies of acute neurological effects in adult humans exposed to tetrachloroethylene. In one study, symptoms of neurological impairment were not reported after exposure to 106 ppm for 1 hour. Neurological symptoms of dizziness and drowsiness occurred at exposure to 216 ppm for 45 minutes to 2 hours; loss of motor coordination occurred at exposure to 280 ppm for 2 hours or 600 ppm for 10 minutes. Volunteers in this study were allowed to leave the exposure chamber when they experienced discomfort. Consequently, exposure times varied and ranged from 3 minutes to 2 hours. In another study, exposure to 100 ppm for 7 hours produced symptoms such as headache, dizziness, difficulty in speaking, and sleepiness. Of five objective tests of central nervous system performance in humans exposed for 7 hours, none showed any abnormality except the Romberg test of balance, which was abnormal for three of the five subjects exposed for 7 hours a day for 5 consecutive days. Only one exposure level (100 ppm) was used in this study.

Subjects exposed to 106 ppm in laboratory studies experienced slight eye irritation; dizziness and sleepiness were reported at 216 ppm; at exposures of 280 ppm or 600 ppm for 10 minutes there was a loss of motor coordination. In another study subjects exposed for 7 hours at 101 ppm complained of eye irritation and subjective symptoms such as headache, drowsiness and sleepiness.

Intense irritation of the upper respiratory tract was reported in volunteers exposed to high concentrations (>1,000 ppm) of tetrachloroethylene.

The liver is a target organ in humans accidentally exposed to high concentrations of tetrachloroethylene. Hepatocellular damage was documented by biopsy in a case study of a woman

exposed occupationally to tetrachloroethylene fumes for 2.5 months. Liver damage also has been diagnosed by the presence of hepatomegaly, icterus, and elevations of serum glutamic oxaloacetic transaminase (SGOT), bilirubin, and urinary urobilinogen. These effects were generally observed several days after an acute exposure resulting in nervous system effects.

Hepatic lesions are also induced in experimental animals during inhalation exposure to tetrachloroethylene. Mice are the species most sensitive to this effect. Hepatocellular vacuolization occurred after a single 4-hour exposure of mice to 200 ppm or greater concentrations of tetrachloroethylene.

Inhalation of vapours or aerosols (mists, fumes), generated by the material during the course of normal handling, may be damaging to the health of the individual.

**Ingestion**

Not normally a hazard due to physical form of product.  
Considered an unlikely route of entry in commercial/industrial environments  
Swallowing of the liquid may cause aspiration of vomit into the lungs with the risk of haemorrhaging, pulmonary oedema, progressing to chemical pneumonitis; serious consequences may result.  
Signs and symptoms of chemical (aspiration) pneumonitis may include coughing, gasping, choking, burning of the mouth, difficult breathing, and bluish coloured skin (cyanosis).  
Many aliphatic hydrocarbons create a burning sensation because they are irritating to the GI mucosa. Vomiting has been reported in up to one third of all hydrocarbon exposures. While most aliphatic hydrocarbons have little GI absorption, aspiration frequently occurs, either initially or in a semi-delayed fashion as the patient coughs or vomits, thereby resulting in pulmonary effects. Once aspirated, the hydrocarbons can create a severe pneumonitis.  
Rats given isoparaffinic hydrocarbons - isoalkanes- (after 18-24 hours fasting) showed lethargy and/or general weakness, ataxia and diarrhoea. Symptoms disappeared within 24-28 hours.  
When tetrachloroethylene (perchloroethylene) is used in the treatment of hookworm (4.5 to 6.5 gm orally) the only adverse effect is inebriation. Transient hepatotoxicity in patients given single oral doses of up to 5 ml have been recorded.

**Skin Contact**

The material may accentuate any pre-existing dermatitis condition  
Dermally, isoparaffins have produced slight to moderate irritation in animals and humans under occluded patch conditions where evaporation cannot freely occur. However, they are not irritating in non-occluded tests, which are a more realistic simulation of human exposure. They have not been found to be sensitizers in guinea pig or human patch testing. However, occasional rare idiosyncratic sensitisation reactions in humans

	<p>have been reported. Spray mist may produce discomfort</p> <p>In common with other halogenated aliphatics, fluorocarbons may cause dermal problems due to a tendency to remove natural oils from the skin causing irritation and the development of dry, sensitive skin. They do not appear to be appreciably absorbed. Harmful: danger of serious damage to health by prolonged exposure through inhalation.</p> <p>Serious damage (clear functional disturbance or morphological change which may have toxicological significance) is likely to be caused by repeated or prolonged exposure. Similar warnings have been issued by IARC for vinyl fluoride. Similarly vinyl bromide exhibited neoplastic and tumourigenic activity in rats exposed by inhalation and is classified by various bodies as potentially carcinogenic.</p> <p>Substances such as chloroprene (2-chloro-1,3-butadiene), are reported to produce an increased frequency of chromosomal aberrations in the lymphocytes of Russian workers. Russian epidemiological studies also suggest an increased incidence of skin and lung cancer following exposure to chloroprene, a result which is not supported by other studies.</p> <p>Generally speaking, the monohalogenated substances exhibit higher carcinogenic potential than their dihalogenated counterparts. Whether additional substitution lessens such hazard is conjectural. Tetrafluoroethylene, for example, produced clear evidence of carcinogenic activity in a two-year inhalation study in rats and mice. <i>National Toxicology Program Technical Report Series 450, April 1997</i></p> <p>Principal route of occupational exposure to the gas is by inhalation.</p> <p>Chronic inhalation or skin exposure to n-hexane may cause peripheral neuropathy, which is damage to nerve ends in extremities, e.g. fingers, with loss of sensation and characteristic thickening. Nerve damage has been documented with chronic exposures of greater than 500 ppm. Improvement in condition does not immediately follow removal from exposure and symptoms may progress for two or three months. Recovery may take a year or more depending on severity of exposure, and may not always be complete. The cancer concern levels of the 14 haloalkanes and haloalkenes, have been rated based on available screening cancer bioassay (pulmonary adenoma assay) and genotoxicity data. Five brominated and iodinated methane and ethane derivatives are given a moderate rating. Beyond the fact that bromine and iodine are better leaving groups than chlorine, there is also evidence that brominated THMs may be preferentially activated by a theta-class glutathione S-transferase (GSTT1-1) to mutagens in Salmonella even at low substrate concentrations. Furthermore, there are human carcinogenicity implications because of polymorphism in GSTT1-1. Human subpopulations with expressed GSTT1-1 may be at a greater risk to brominate THMs than humans who lack the gene.

Six, two, and one haloalkanes/ haloalkene(s) are given low-moderate, marginal, and low concern, respectively.
