5 Fire Fighting Measures

Suitable Extinguishing Media:

Foam and dry chemical powder. Do NOT use a solid water stream or foam on burning molten material.

Specific Hazards Arising from the Chemical:

No hazardous decomposition products known.

Product will burn in a fire but propagates flames with difficulty. Finely divided powders suspended in air or some other oxidising medium may form explosive dust-air mixtures and result in a fire or dust explosion (including secondary explosions).

Stop leak if safe to do so and collect spilled material, avoiding the generation of dust. Use only non-sparking tools.

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dusts. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use.

Conditions for Safe Storage:
